Victims Advocate and Survivor

Julie Nicole Wallach is a mother, speaker, author, coach, and storyteller dedicated to reducing the stigma of shame and aiding in the healing of sexual assault survivors. She was a leading member and spokesperson in the landmark \$243.6 million lawsuit against UCLA involving gynecological oncologist Dr. James Heaps. Wallach has supported trauma survivors for the past 20 years.

CAPS addresses animal suffering through investigations, outreach, legislation, legal advocacy, consumer assistance, rescue, and shelter reform.

Executive Director, About My Father's Business Pastor Kathy, dedicates countless hours to organizing supplies for individuals facing homelessness and regularly visits those living in encampments, vehicles, and RVs.
